The Court of Common Pleas was established by the Dongan Charter of 1686. Also known as the Mayor ' s Court, it was a civil court with jurisdiction limited to the City of New York. In 1691, the court ' s jurisdiction was extended throughout the State and the court was continued under the Constitution of 1777.

By Chapter 4 of the Laws of 1691, the New York Assembly established the New York Supreme Court of Judicature with the same common law jurisdiction as the English Courts of King's Bench, Common Pleas and Exchequer. The court did not have jurisdiction in equity — that jurisdiction was vested in the Court of Chancery.
